Who can use this form?

People with Medicare who want to join a Medicare Advantage Plan. To join a plan, *you must:*

- Be a United States citizen or be lawfully present in the U.S.
- Live in the plan's service area
- Be a resident in an American Health Advantage of Idaho contracted nursing home facility

Important: To join a Medicare Advantage Plan, you must also have both:

- Medicare Part A (Hospital Insurance)
- Medicare Part B (Medical Insurance)

When do I use this form?

You can join a plan:

- Between October 15–December 7 each year (for coverage starting January 1)
- Within 3 months of first getting Medicare
- In certain situations where you're allowed to join or switch plans

What do I need to complete this form?

- Your Medicare Number (the number on your red, white, and blue Medicare card)
